Annual rent: \$65,636.90

Lease Year 3: March 1, 2019 - Feb 29, 2020 (3% increase over previous year)

Price per sqft: \$29.56

Base rent per month: \$5633.64

Annual rent: \$67,603.72

2. Except as herein amended, all terms and conditions of the Lease shall remain in full force and effect.

3. Landlord shall provide, at Landlord's sole cost and expense, new carpet in Tenant's space. Tenant shall have the right to choose color. Landlord shall install carpet within 45 days of Lease Commencement.
